INITIAL NARRATIVE

SYNOPSIS:

Lincoln Twp Police Dept was contacted by the Dept of Human Services (DHS) regarding a possible Criminal Sexual Conduct (CSC) of an eight year old. The allegations in this complaint include penetration involving the eight year old a fifty three year old male, that penetration being penis/vagina.

OFFICER'S INITIAL INFORMATION:

On September 28, 2011 at approximately 1:00 p.m. reporting officer received a call from DHS worker Jody Haygood. Ms. Haygood advised that the subjects, M.K. and A.K., were currently going through counseling with Counselor Gloria Gillespie. She stated that she received information from Ms. Gillespie that there was disclosure of sexual contact between M.k, A.K. and a suspect by the name of Larry Hale, who is a friend of M.k and A.k;s parents.

Ms. Haygood also advised that she has had conversations with M.k and A.k 's foster parents, that being their Aunt and Uncle J.k and his wife. She states that J.K. has advised her that A.K. was riding in a car on September 25, 2011 and she brought up Larry Hale. J.K. provided written notes on a conversation that he overheard. Ms. Haygood did forward the written notes to reporting officer that were made by JK and also provided reporting officer with written information regarding these allegations. Both of these items will be attached to this original complaint.

CONTACT WITH COUNSELOR; GLORIA GILLESPIE:

Reporting officer is familiar with Ms. Gillespie and her occupation. Reporting officer does note that she works with victims of sexual abuse and M.K. and A.K. are victims of sexual abuse prior to this complaint. Reporting officer spoke to Ms. Gillespie on the telephone on September 29, 2011. Ms. Gillespie stated that A.K., M.K., and P.K. are currently in counseling with her. She stated that she has spoken to M.K. and that M.K. made statements about sexual contact with Larry Hale.
