He only did it one time to me and I told him he is not supposed to and he quiet and he made a mistake." I asked her if she ever told anyone else and she said, "First time I told because I didn't want to but I want to tell the truth." She told me she was eight years old when this happened. I asked her where they were living and she said, "With my mom she was sick so I went to my grandpa's house for the night."

She told me that her grandma is in the living room. She then stated, "My grandma asked me before if grandpa has touched me, but I told her no. She said if he did she call the police. That was last Christmas." I asked her if her grandpa touched her before or after Christmas and she said, "Before and after." I asked her what Grandpa did and she said, "Put his hand on my belly." She told me that this happened more than one time. I asked her if grandpa had touched her on her private part and she said, "No private part, just belly." She denied that there was ever a time that he made her touch his private part.

I asked her how her clothes were when this happened and she said, "On. I was hot and grandma came to check if I had a fever. She checked my belly for fever." She clarified that when grandpa did that it made her feel uncomfortable.
